#### 5. CHAIRPERSON'S REPORT – Fiona Lawson

"Thank you all for attending the WCNL 2021 AGM. So last year I started with "The first, and hopefully, the last by Zoom!" Not to be, however, life is returning to some normality for which we are all thankful for! So we didn't quite make two good seasons of competitive netball this year but we did make one – and what a great summer season it was. I want to start by thanking you, the teams. You entered into this summer league with modified rules and I am sure, mixed emotions – keen to get back to netball but also a little apprehensive about it. I know we all forgot about the modified rules sometimes but games were played in high spirits and it was great to see so many people enjoying our sport again.

I also want to thank the WCNL committee members – without their hard work no netball would happen, we've had to adapt rules on and off court, make last minute changes, all of which can be a heavy workload for volunteers. I want to make a special shout-out to

Sarah, Fixtures Secretary – she works tirelessly to sort venues, which is getting harder and harder, she arranges all the fixtures, then re-arranges, and re-arranges. This last summer season we had an issue with one of the venues after the first week so she had to move games to other venues, ensure all teams were aware, etc. – it's just non-stop for her. Sarah, thank you from everyone!

We do have some co-opted positions available - co-opted positions do not have any specific responsibility, but they make a valuable contribution at meetings (every 6 weeks or so) and help to support other members of the committee. I want to just mention why we had to rearrange venues early on – spectators and dogs. Now we are reverting to normal rules, we will update our WCNL COVID policy to still include hand/ball sanitising, etc, and we will remove the no spectators. However, we would appreciate you keeping spectators to a minimum especially where we are playing indoors as there is a lack of space and we still want to maintain distancing where we can to keep everyone safe. The issue with dogs (less relevant for winter) is a more serious one. This message needs to get out to ALL teams and ALL spectators – we cannot have dogs on any school premises. I appreciate whilst you are playing, your spectator uses the opportunity to take the dog for a walk but it cannot be on any school playing fields. This is not our rule, this is a venue rule, and when broken, they then ban us from using their courts. If any spectators with dogs are found on any school grounds they will be asked to leave – this is not a temporary COVID rule, it is a venue rule we must adhere to now and in the future. Please ensure you pass this message onto all of your players.

We will enter into winter league 2021 with no on court rule modifications – however safety is still essential to reduce transmission so many of the off court mitigations will be left in place e.g. sanitising. Also, in line with Government guidance anyone testing positive for COVID-19 must not attend any netball activity and should isolate for 10 days.

Fingers crossed in 2021/22 we will manage two great competitions and we will see the return of our tournaments. Once again we will attempt to support the Worcestershire Breast Cancer Centre as our nominated charity. We do have a position on the committee available for a Tournament Secretary – if we do not fill this position we will continue to run at least one regardless."

## Appendix 1 – Worcester City Netball League Profit and Loss 2020/21

"We are maintaining a healthy balance — this is essential in winter as indoor court fees are so much more expensive and we have to pay monthly. We are still happy to invoice teams twice per year, however we would ask again invoices are paid promptly. There are not many sports where you can play before you pay — we try and give teams the chance to 'collect subs' before we issue invoices and just ask, in return for this, you pay as soon as the invoices are issued. Failure to do this will result in a surcharge being made. We are no longer accepting cheque payments — please can you ensure payments are made by BACS. If anyone has any finance questions please put them in the chat and I will get answers across to you.
